ADMISSION NOTICE: Extension of Last Date For Submission of Application Form FOR FIRST YEAR OF POST HSC DIPLOMA COURSES IN PHARMACY FOR ACADEMIC YEAR 2024-25

It is Mandatory for all the Institutes in the State conducting Diploma in Pharmacy course to obtain approval from Pharmacy Council of India, New Delhi (PCI) and affiliation from Maharashtra State Board of Technical Education (MSBTE) to run the course for every academic year. Most of the Existing institutes conducting Diploma in Pharmacy Course have received PČI approval to continue the Diploma in Pharmacy course for the academic year 2024-25 but process of affiliation of MSBTE is under process and some more time is expected to complete the same.

Hence, this Notice is being issued for Extension of Last Date for Online Registration & uploading of documents, Documents Verification and Application Form Confirmation for admissions to First Year of Post HSC Full Time Diploma in Pharmacy Course in the Government, Government Aided, University Managed and Unaided private educational institutes for the Academic Year 2024-25 in the State of Maharashtra.
